NOTICE OF PUBLIC MEETING

NOTICE IS HEREBY GIVEN pursuant to Section 551.041 of the Texas Government Code, that the Navigation and Canal Commissioners of the VICTORIA COUNTY NAVIGATION DISTRICT (the "District") will meet on October 18, 2016, at 1:00 p.m. at the District's administrative office, located at 1934 FM 1432, Victoria, Texas.

The subjects of such meeting shall be:*

- 1) Approval of minutes of the meeting held September 20, 2016.
- 2) To receive public comment (limited to three minutes per person).
- 3) To receive the following Staff and Committee reports:

A. Executive Director/Executive Committee - Business recruitment; development of the Port of Victoria North and South Industrial Site; leases and contracts; federal, state and local governmental affairs; rail issues; USACE update; upcoming Port and industry events; and other related administrative and governmental matters.

- i) To review, discuss and consider approval of a proposed Option Agreement between the District and Castleman Power Development, LLC, granting an option to enter into a ground lease covering three (3) acres within the Port of Victoria North Industrial Park, and take appropriate action.
- ii) To review, discuss and consider approval of a proposed amendment to the Ground Lease entered into between the District and Eagle Ford Field Services, LLC, and later assigned to and currently held by Enlink Midstream, as Tenant, and take appropriate action.
- iii) To discuss legislative issues and topics anticipated to be taken up in the upcoming 85th Texas Legislative Session, potential legislation impacting the District and its operation and development of the Port of Victoria, receive recommendations with respect to the retention of a legislative consultant, and take appropriate action.

B. Director of Port Operations - Activities and matters related to waterborne traffic activity; operations at the Port of Victoria; and Port tenant updates.

- i) To receive and review information regarding the District's current and anticipated costs for upkeep and maintenance of its various properties, receive staff recommendations regarding an upkeep and maintenance plan for said properties, receive staff recommendations with respect to requests to lease certain properties, and take appropriate action.

- C. Finance Committee - Activities and matters related to financial results; investments; insurance; financial management issues; project financing; budgeting and tax rate analysis; and financial audit process.
 - i) Receipt of monthly financial reports, and approval of payment of accounts payable.

- D. Facilities Committee - Activities and matters related to the Channel to Victoria; capital projects and other projects; infrastructure and maintenance issues and planning; transportation issues; safety and security measures; and other related facility engineering or environmental matters.
 - i) To receive information and recommendations from the District's Engineer regarding proposed Change Order No. 001 to VCND's contract with Derrick Construction Co., Ltd., in connection with the North General Dock Repair Project, adding \$31,248.98 to the cost of the project as a result of delays caused by the USACE's permitting process for the project, and take appropriate action.

- E. Advancement & Development Committee - Activities and matters related to public affairs; industry meetings and Port presentations; Port events; trade and new customer development activities; advertising and web activity; Foreign-Trade Zone and other related trade development or community relations matters.
 - i) To receive a report from The Emmett Company regarding the potential development of the Port of Victoria facilities and properties, and strategic planning matters relating to the District.
 - ii) To receive an economic development report from representative(s) of the Victoria Economic Development Corporation, and consider further action with respect to pending VEDC projects involving the Port of Victoria.

- 4) To receive the report of the District's Legal Counsel.

- 5) To discuss the status of negotiations with potential customers of the Port of Victoria and consider approval of agreements relating to same.


- 6) To discuss and deliberate the purchase, exchange or lease of property and other real estate matters, including requests for easements and/or permits.
