



NOTICE OF PUBLIC MEETING

NOTICE IS HEREBY GIVEN pursuant to Section 551.041 of the TexasTexas Government Code, that the Navigation and Canal Commissioners of the VICTORIA COUNTY NAVIGATION DISTRICT (the "District") will meet on February 21, 2017, at 1:00 p.m. at the District's administrative office, located at 1934 FM 1432, Victoria, Texas.

The subjects of such meeting shall be:*

- 1) Approval of minutes of the meetings held January 17, 2017, and February 6-8, 2017.
- 2) To receive public comment (limited to three minutes per person).
- 3) To receive the following Staff and Committee reports:

 - B. <u>Director of Port Operations</u> Activities and matters related to waterborne traffic activity; operations at the Port of Victoria; and Port tenant updates.
 - i) To receive and review staff recommendations regarding proposed additions and/or revisions to the Port of Victoria's current Tariff with respect to the provision and charges for security services on the POV Liquid Docks, and take appropriate action.
 - C. <u>Finance Committee</u> Activities and matters related to financial results; investments; insurance; financial management issues; project financing; budgeting and tax rate analysis; and financial audit process.
 - i) Receipt of monthly financial reports, and approval of payment of accounts payable.
 - D. <u>Facilities Committee</u> Activities and matters related to the Channel to Victoria; capital projects and other projects; infrastructure and maintenance issues and planning; transportation issues; safety and security measures; and other related facility engineering or environmental matters.
 - i) To receive information and recommendations from the District's Engineer regarding proposed Change Order No. 002 to VCND's contract with Derrick Construction Co., Ltd., in connection with the

North General Dock Repair Project, adding \$6,980.94 to the cost of the project to account for overages in Stabilized Sand and Select Fill required for completion of the project, and take appropriate action.
