NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.0271 per \$100 valuation has been proposed by the governing body of VICTORIA COUNTY NAVIGATION DISTRICT.

PROPOSED TAX RATE \$0.0271 per \$100 NO-NEW-REVENUE TAX RATE \$0.0263 per \$100 VOTER-APPROVAL TAX RATE \$0.0273 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for VICTORIA COUNTY NAVIGATION DISTRICT from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that VICTORIA COUNTY NAVIGATION DISTRICT may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that VICTORIA COUNTY NAVIGATION DISTRICT is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 10, 2025 AT 10:00 AM AT THE VICTORIA COUNTY NAVIGATION DISTRICT ADMINISTRATION OFFICE 1934 FM 1432, Victoria, TX 77905.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, VICTORIA COUNTY NAVIGATION DISTRICT is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Navigation and Canal Commissioners of VICTORIA COUNTY NAVIGATION DISTRICT at the District's offices or by attending the public meeting mentioned above.
